

**SLETBA BOWLER OF THE YEAR AWARD  
POINT SYSTEM RULES  
Beginning January, 2018**

**QUALIFICATIONS:**

- a. All SLETBA members are qualified and are automatically considered contenders as soon as membership is renewed.
- b. Non-SLETBA or Guest Members are not qualified to join. However, if their status is changed as SLETBA member, their earning points shall commence only from the date and time of the status change.
- c. The **BOWLER OF THE YEAR** shall be the bowler garnering the highest points earned from the following SLETBA games:
  - Monthly Finals
  - Classic Showdown/Ruler of the Lanes
  - ANNUAL Tournament
  - SLETBA OPEN
- d. When guest bowler wins in any of the point-earning positions, the SLETBA member who immediately follows them in the standing or hierarchy down the line shall be credited with the corresponding points.
